## A MESSAGE FROM CLEVELAND CITY COUNCIL

### Dear Cleveland Residents,

Our city, at last, is beginning to slowly and steadily open up its private and public operations after months of an ordered emergency lockdown.

An official call for concern is still in place, but we are seeing signs of new life as some restrictions on retail operations are easing, while at the same time strongly urging various safeguards.

So far, these safeguards have helped to slow the spread of **Covid-19**.

City Council proudly recognizes all those who are taking this public health emergency seriously and are practicing safe distancing from one another and wearing masks in public places.

The **masks are very important for slowing this deadly pandemic** and now that Governor Mike DeWine has ordered face coverings be worn in public places in Cuyahoga and other counties hit hardest by Covid-19 (see page 2), we can hope to see some promising signs toward slowing this aggressive virus.

This is a vital time for us as the warm weather has been drawing more and more people outdoors, resulting in a possible relaxation of the simple acts of precaution.

But remember, these simple acts have

had a significant impact in the fight against this world-wide pandemic. So we are urging citizens to stay vigilant under this ongoing emergency and to help each other from spreading this dangerous virus.

But the work of City Council continues. Council recently approved a resolution declaring **racism as a public health crisis** and setting up a working committee of experts to study and pursue policies and strategies to bring about racial equity.

The resolution, drafted by council earlier this year, comes at a time when the nation sees a white police officer in Minneapolis take the life of a black man by kneeling on his neck, cutting off his breathing.

It also comes at a time when the Covid-19 virus is killing blacks and minorities at a higher rate than whites, revealing inequities in health care and healthy environments.

Finally, it comes at a time when minorities have become a solid majority in growing unemployment lines.

In Cleveland and in cities across the nation, racism is systemic and we, as citizens

grounded in principles of morality and justice, must come together to put an end to this glaring division.

We cannot tolerate police misconduct; we cannot tolerate people suffering in unsafe living conditions; we can not tolerate all citizens from having access to fresh food and clean air; we cannot tolerate any form of racial oppression.

We are living in a dangerous time with a deadly virus. And all of us, regardless of race or creed, must rely on each other to stay safe and healthy. **Please do not hesitate to call your council representative with questions, comments or concerns** (see listing on page 4). City Council has been meeting electronically for public hearings and legislative sessions (see page 3 for details).

And though Covid-19 has limited the hours at City Hall, be assured that we are still working for you around the clock.

Stay safe, stay healthy.

The Census will begin to send out workers into the community to go to homes that haven't replied to the Census. With the pandemic still raging, please help the workers by filling it out so they don't have to come to your house. **Millions of dollars for services, schools, roads, programs are at risk for Clevelanders if it isn't filled out.**

**BY PHONE** You have the option of completing the questionnaire by phone. To begin, call **844-330-2020**.



**MAIL** The Census Bureau began mailing paper questionnaires in mid-April to homes that had not yet responded. If you have not already responded, **please complete and mail back your form.**

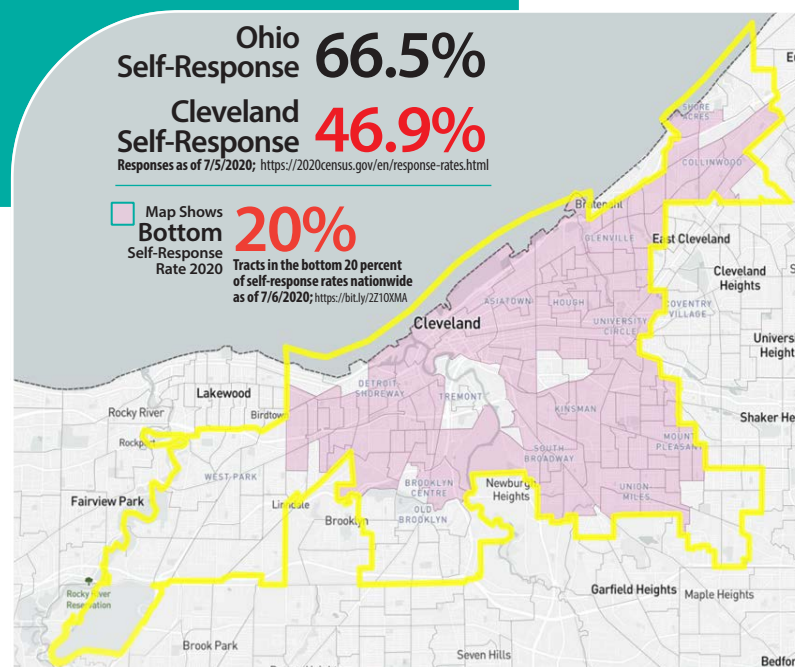

# MASKS REQUIRED IN CLEVELAND AND CUYAHOGA COUNTY

With Covid-19 cases and hospitalizations rising in Ohio – elected officials in some areas have instituted requirements that everyone must wear masks.

**Governor Mike DeWine recently mandated face coverings in public in all counties that are designated Red Alert Level 3 or Purple Alert Level 4 Public Health Emergency.** To find out more go to: <https://coronavirus.ohio.gov/wps/portal/gov/covid-19/home>. Ohioans can also call 1-833-427-5634 to ask questions from 9 am to 8 pm every day, including weekends.

**Cuyahoga County, along with six other Ohio counties are designated Red Alert Level 3 which indicates a very high risk of exposure and spread.** Those living in or visiting counties designated as Red Alert Level 3 or Purple Alert Level 4 are required to wear a face covering:

- In any indoor location that is not a residence;
- When outdoors and unable to consistently maintain a distance of six feet or more from individuals who are not members of their household; or
- While waiting for, riding, driving, or operating public transportation, a taxi, a private car service, or a ride-sharing vehicle.

The governor’s order does not apply to children under 10 or any other minor who cannot safely wear a face covering. People who violate the orders can be punished with a misdemeanor charge.

When a county improves and moves out of the red, the governor’s order will be lifted.

However, **Mayor Frank G. Jackson has issued an order requiring face coverings for everyone two and older, except for medical issues.** Typically, cities and counties must follow state mandates but can make them stricter. Penalties for those who don’t follow the face covering mandate are under discussion. The mayor’s orders include:

- Mandatory masks for all individuals out in public or in public spaces including businesses, restaurants etc.
- Maximum capacity at any bar, restaurant, entertainment venue cannot exceed 50% of allowable capacity and must comply with social distancing standards.
- Mass Gathering Orders are still in effect. If incidents of more than 10 persons are gathered not wearing masks, enforcement actions will be taken.
- If an establishment has an employee or a patron, who has tested positive for Covid-19, then the establishment must be sanitized to the standards of the Cleveland Health Department, failure to demonstrate such sanitization will result in the facility being shut down.

## HOW CAN I PREVENT FROM GETTING COVID-19?

There are steps you can take to help prevent the spread of COVID-19:

- Stay home unless you must leave, for essential reasons, especially if you are sick
- Frequently wash your hands with soap and water. If that is not available, use hand sanitizer with at least 60% alcohol
- Cover your mouth/nose with a tissue or sleeve when coughing or sneezing
- Avoid being within 6 feet of those outside of your household
- Clean and disinfect frequently touched surfaces and objects
- Wearing face-coverings (home sewn masks, handkerchiefs, bandanas) is recommended by the CDC and the Ohio Department of Health

**The Greater Cleveland Food Bank will distribute meals every Thursday now through August 7. Each child will receive enough food for five meals. Food Bank staff will also help adults apply for food assistance and other critical benefits.** Children 18 and under can receive Grab & Go meals at the following Cleveland Public Library (CPL) branches:

**Fulton Branch** (3545 Fulton Rd): 12:30 pm - 2:00 pm

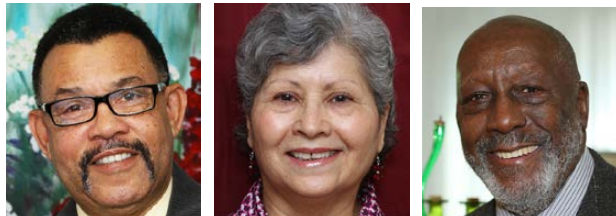
## Senior Services



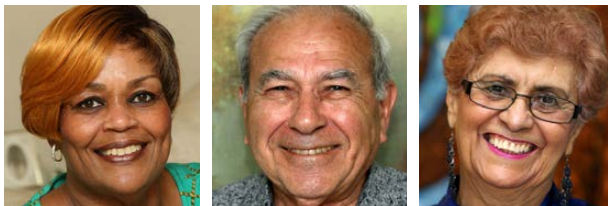
Cleveland Care Calls is an automated telephone reassurance system being offered to Cleveland Seniors 60 and over or adults 18-59 with a disability by the Department of Aging and Public Safety. Through this computerized system, the individual receives a call, on the days they request, Monday through Friday, to check on their well-being.

**They can select a time to receive the call between 7 AM - 11 AM. If the individual does not respond to his/her call:**

- System will make several additional attempts in a thirty (30) minute period.



**For Cleveland Seniors

- If no response within the thirty minute period, the Department of Aging will then contact any person that the senior has designated as an emergency contact.
- If the individual or any of his/her contacts cannot be reached, the Department of Public Safety may be asked to make a home check on the individual in question.

## Coronavirus Infection Data Shows Glaring Racial Disparity

Whether in big cities or little towns, Black and Latino communities across the United States are disproportionately affected by the coronavirus, becoming three times as likely to be infected as white residents in their communities.

That glaring disparity is backed by data recently released by the federal government. It also shows that blacks and Latinos are twice as likely to die from the virus as white people.

Some public health experts say the disparity is due in part to underlying health problems among these minorities – health problems largely due to systemic racism in the United States.

The new federal data, reported by the New York Times, shows that the racial disparity spanned the entire nation throughout urban, suburban and rural areas and across all age groups.

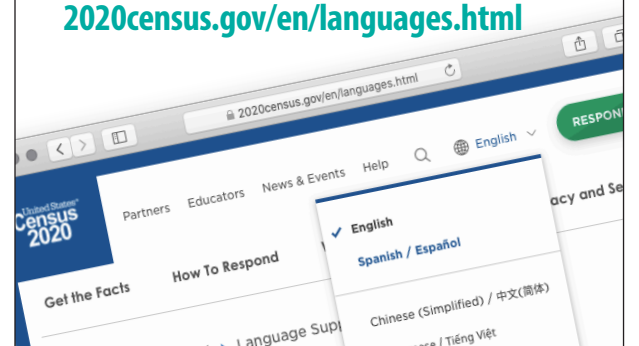
## United States Census 2020 Language Support Ayuda en varios idiomas
