The homestead exemption allows lowincome senior citizens and permanently and totally disabled Ohioans to reduce their property tax bills, by shielding some of the market value of their homes from taxation. The exemption, which takes the form of a credit on property tax bills, allows qualifying homeowners to exempt up to \$25,000 of the market value of their homes from all local property taxes.

For example, through the homestead exemption, a home with a market value of \$100,000 is billed as if it is worth \$75,000.

The exact amount of savings varies from location to location. But overall, across Ohio, qualified homeowners saved an average of about \$495 per taxpayer during the 2015 tax year. The tax exemption is limited to the homestead, which Ohio law defines as an owner's dwelling and up to one acre of land. The value of the exemption may not exceed the value of the homestead. The 2017 income threshold is \$31,800, the 2018 threshold is \$32,200, the 2019 threshold is \$32,800, the 2020 threshold is \$33,600 and the 2021 threshold is \$34,200. To apply, complete the application form (DTE 105A - Homestead Exemption Application Form for Senior Citizens, Disabled Persons, and Surviving Spouses), then file it with your local

county auditor. The form is available on the Department of Taxation's website and is also available from county auditors. Applications for real property must be filed on or before December 31 of the year for which homestead is sought. Applications for manufactured or mobile homes must be filed anytime on or before the first Monday in June of the year preceding the year for which homestead is sought.

If you witness dumping in progress call 911. Observe and write down what the person/people look like as well as the license plate, plus the car make, model, and color. You can also call 664-DUMP, to report any dumping. Citizens can report concerns or let Clean Cleveland know how crews are doing by emailing CleanCLE@city.cleveland.oh.us or calling 3-1-1. Council is adding funding to the Cleveland-Cuyahoga County Environmental Crime Task Force.

And, as always, be the change you want to see by keeping your yard free of litter. Neighbors can also join together and organize community clean-ups. Councilman Bishop and the Ward 2 Office will be on the look out and will make sure these illegal dumpers are charged and fined. Also, please be aware of bulk pickup guidelines and remember it's ALWAYS the first full week of the month.

Speeding Ticket? Go Online and No Points

Citizens can go on line and enter a plea of guilty for minor misdemeanor traffic violations – like speeding – and the offense is reduced to a minor misdemeanor unsafe motor vehicle which is a NO POINTS offense. The fine is then \$55 and court costs.

You can also pay a waste ticket, a parking ticket and more online.

Eligible homeowners will have incomes at or below 120% AMI for the county, and will be current on their real estate taxes or currently in a payment plan with the county.

Eligible homes are located in communities within Cuyahoga County and are single-family and owner-occupied.


Eligible Repairs



Register NOW to vote or update your **Voter Registration information**

Voters must be registered in Cuyahoga County in order to vote in any election. In order to vote in Cuyahoga County, you must meet the following requirements:

- You must be a United States Citizen.
- You must be at least 18 years old on the day of the General Election.
- You must be a resident of Ohio for

City of Cleveland Exterior Paint Program Returns

The City of Cleveland invites residents to take advantage of its 2021 Exterior Paint Program. Apply now.

The Exterior Paint Program provides paint and materials to homeowners who wish to paint the exterior of their homes. Labor is not included. The goal for 2021 is 500 homes with a total allocation of \$500,000 for the program.

Homeowners, as well as tenants, who meet income guidelines, are welcome to apply for the program. Funds cover the cost of up to \$1,500 for

owner occupants or up to \$750 for tenants in paint and materials, though restrictions do apply. Inspections of the property must also be conducted. Painting must be completed by Oct. 31, 2021.
