COVID-19 Vaccine Distribution

Many Ward 15 residents are anxiously awaiting an opportunity to receive a COVID-19 vaccination. Ohio is following a phased approach to vaccine administration and we are now in "Phase 1B", which will primarily target Ohioans age 65 and older, others at high risk, and helping K-12 students get back in the classroom by March. The following is vaccine distribution information specific to city of Cleveland residents:

There are limited doses of vaccine available nationwide, and the Cleveland Department of Public Heath (CDPH) is receiving limited quantities. However, in addition to CDPH there are over 20 other entities dispensing vaccine in Cleveland for Phase 1B.

It is recommended that you start by contacting your own health care provider.
You may also search the Ohio Department of Health website by ZIP Code for other providers:



https://vaccine.coronavirus.ohio.gov/. You may also call the United Way of Cleveland 2-1-1 call center to assist you in finding a vaccine provider.

In addition, city of Cleveland residents may join the CDPH's Phase 1B waitlist by calling their Call Center at 216-664-2222, Monday - Friday, 9a to 5p. Visit the CDPH COVID-19 website at www.clevelandhealth.news/covid19-vaccine for updates.

Even after you've been vaccinated, please continue to wear a mask, practice social distancing and frequent hand washing. This will be necessary until over 80% of the population has been vaccinated.

For your convenience the 2021 City of Cleveland Division of Waste Bulk Pick-up Calendar is on page four of this newsletter. In addition to bulk pick-up dates, the calendar includes information about proper waste set out. Here are some tips to make sure your waste collection is compliant with city set out guidelines:

Rule of Three

Remember that the *limit for bulk pick-up is three* **items.** Residents may leave out for collection items such as appliances, tables, chairs, mattress box springs, couches and furniture. All mattresses, box springs and cloth furniture must be wrapped in plastic. In addition to the three items, residents may leave out up to four tires. The City does not accept construction material. Boxes and loose bags are not bulk items. Carpet must be cut and rolled into 3-foot long pieces and must not exceed 40 pounds.

Waste Set Out Rules

The Division of Waste also reminds residents of the following waste regulations:

- Only waste in officially issued City carts will be accepted, and loose trash or bags outside City roll carts will not be accepted.
- Construction materials, hazardous waste, bricks, dirt, concrete, cinder blocks, auto parts, loose metal items, medical waste or fluorescent tubes WILL NOT BE ACCEPTED in or outside of roll carts.
- No wet paint should be placed in roll carts. All paint cans should be dry before they are placed in roll carts.
- Do not place hot charcoal ashes in roll carts. For further information regarding waste collection, please call the Division of Waste Collection at (216) 664-3711 or visit www.clevelandohio.gov

The Lead Safe Cleveland **Coalition believes no child** should ever be lead poisoned.

While poisoning typically occurs in early childhood, it can have long-term effects on exposed individuals.

The lead poisoning crisis has a housing solution. Exposure of leaded dust in a home is the main source of poisoning for Cleveland's children. If you live in a home built before 1978, lead hazards may be present, even if you do not see chipping or peeling paint. Most children are poisoned by swallowing lead dust from hand to mouth activity. It takes less than a teaspoon of dust - the size of a sugar packet - to cause serious, long-term harm.

Beginning March 31, 2021, the City of Cleveland is requiring all residential rental units to receive a Lead Safe Certification. To obtain a Lead Safe Certification, rental property owners must pass a Lead Clearance conducted by an independent, certified lead safe worker. Certification will be rolled out in phases: most rental properties in Ward

Eligible hardworking families can receive up to \$6,600 at tax time with the EITC. This service is available for those who qualify and make under \$57,000 a year. All returns are completed by IRScertified volunteer tax preparers at conveniently located tax sites. The two closest tax sites for Ward 15 residents are:

- Lin Omni Center, 3167 Fulton Road, Cleveland, OH 44109 ENGLISH AND SPANISH
- *All tax sites require an appointment there will be no walk-in appointments available.

Bridget Kent Márquez is the Healthy Homes Coordinator serving the Detroit Shoreway, Cudell, Edgewater and West Boulevard Neighborhoods. The Healthy Homes Initiative was created by the City of Cleveland's Department of Community Development in order to connect residents with home repair resources.

Various home repair resources are available, including grants as well as zero or low interest loans from a variety of non-profit, public, and private institutions. These home



repair programs can include projects such as energy efficiency upgrades with furnace and hot water tank replacement, exterior home repairs, and more. Each program comes with its own qualifying factors, such as income guidelines and household guidelines.

Bridget speaks both English and Spanish

Applications now open for the City of Cleveland Paint Program


The City of Cleveland has released the 2021 Exterior Paint
