#### **Greetings Ward 2 constituents,**

Winter, and the dreaded snow, comes early to Cleveland. But I hope your summer and autumn were memorable and safe and you got to spend fun times with your loved ones. The holiday season is upon us, and as someone said it "is a perfect time to reflect on our blessings and seek out ways to make life better for those around us."

As Chairman of the Municipal **Services and Property Committee, I** called a hearing to review the city's winter storm preparedness in anticipation of **upcoming inclement weather.** Public Works Director Frank Williams reported that the following projects are currently underway:

- Hiring 26 more drivers training began in October
- Purchasing two additional salt trucks, with more on the way, bringing the total to 60 trucks, with another 20 on

# The Union-Miles Learning Center is Open!

"The Union-Miles Learning Center, opened by JumpStart and Verizon, is fully open," says Councilman Bishop, "and I hope residents will take advantage of it."

It's for all community members—from youth to adults. The center, managed by Jumpstart, is within the Earle B. Turner Recreation Center at 11300 Miles Ave.

#### The goals of the center:

- ▶ Bridge the digital divide so all residents have access to computers, as well as newer and emerging technology including 3D Printers, Laser Cutter, Audio Equipment, Background Screen, DSLR Camera, Lighting, Microphone, Podcast Equipment, Smartphone Recording, Stop Motion Kit, VR System and more.
- Institute digital skills-based courses and trainings for both youth and adults of the various equipment.
- Advance residents, small businesses and others

through access to the new and emerging technologies and—resulting in outcomes such as business/job growth, reemployment, upskilling (higher wages), and more students/adults advancing education related to STEM to participate in the innovation

The Learning Center has "maker spaces," classrooms as well as a recording studio and both an augmented reality and virtual reality stations.

Residents have access to computers, high-speed internet, maker and design software, as well as training on Maker technology (3-D printer, for example), recording studio access and support, as well as workforce development for youth and adults. And for those that need it, basic computer training, so they can advance to the newer technologies. There will also be field trips, afterschool programs and clubs.

#### **Affordable Connectivity Program**

The Affordable
Connectivity Program is an
FCC benefit program that
helps ensure that households
can afford the broadband
they need for work, school,
healthcare and more.



The benefit provides a discount of up to \$30 per month toward internet service for eligible households. Eligible households can also receive a one-time discount of up to \$100 to purchase a laptop, desktop computer, or tablet from participating providers if they contribute more than \$10 and less than \$50 toward the purchase price.

This program is limited to one monthly service discount and one device discount per household.

#### Who Is Eligible for the Affordable Connectivity Program?

A household is eligible for the Affordable Connectivity Program if the household income is at or below 200% of the Federal Poverty Guidelines, or if a member of the household meets at least one of the criteria below (visit **www.fcc.gov/acp** for the complete list):

- · Received a Federal Pell Grant during the current award year;
- Meets the eligibility criteria for a participating provider's existing low-income internet program;
- Participates in one of these assistance programs:
  - » Free and Reduced-Price School Lunch Program or School Breakfast Program, including at U.S. Department of Agriculture (USDA) Community Eligibility Provision schools;
  - » SNAP;
  - » Medicaid;
  - » Housing Choice Voucher (HCV) Program (Section 8 Vouchers);
  - » Project-Based Rental Assistance (PBRA)/202/811;
  - » Public Housing;
  - » Supplemental Security Income (SSI);
  - » WIC;
  - » Veterans Pension or Survivor Benefits;
  - » or Lifeline

#### Two Steps to Enroll

- 1. Go to **AffordableConnectivity.gov** to submit an application or print out a mail-in application.
- 2. Contact your preferred participating provider to select a plan and have the discount applied to your bill.

Some providers may have an alternative application that they will ask you to complete. Eligible households must both apply for the program and contact a participating provider to select a service plan.



# Waste & Recycling Guidelines and Services



#### **Equipment & Setout Guidelines**

The City of Cleveland provides black, 96-gallon trash carts, and (upon request) blue, 64-gallon recycling carts, for weekly trash and recycling collection from all single-family homes, and multi-family homes up to four (4) units. All waste is collected at the "curbside" area, between the curb and the sidewalk, or the property line.

#### **Set-Out Guidelines**

- Place carts curbside the night before collection, or no later than 7:00 am on collection day.
- All waste must be inside the cart.
- Do not place items in carts that exceed the height of the cart
- Place carts at least 3 feet apart to allow room for the truck's arm to grip them.
- Place carts so the opening faces the street.
- Do not lean items against carts, or place them in front of the carts.

- Yard Waste and Bulk waste should not lean against or block access to trash and recycling carts.
- Each week, residents may set out:
  - Up to 20 bundles of brush/tree branches;
  - 20 bags of yard waste;
  - 4 tires without rims;
  - 3 bulk items (during bulk week), and all City-issued carts. Larger, uncontained set outs could result in fines.
- Please use off street parking on collection day, if possible.

#### Residential Drop-off locations

#### **Dumpster Services**

Dumpster services are available to City of Cleveland residents for neighborhood events, home renovations, other residential needs, and ongoing services for multiunit rental properties. To get available sizes and current fees, or to request a dumpster, call 216-664-3162.

#### **Dead Animals**

The Division of Waste removes dead animals from public areas (not private yards). To report a dead animal, call 3-1-1 (216-664-3711).

### **Disposal Tips**

#### **Household Hazardous Waste**

Oil, cleaners, solvents, pesticides, and other household chemicals can be flammable, toxic, or corrosive. The Division of Waste accepts household hazardous wastes like these on the first Friday of the month, at two locations: Carr Center (5600 Carnegie Ave.) and the Ridge Road Transfer Station (3727 Ridge Road).

#### **Construction & Demolition Debris**

The Division of Waste does not collect, for trash or recycling, any waste resulting from the construction, renovation, or demolition of a building. This includes concrete, wood, brick, dirt, drywall, shingles, siding, toilets and sinks. Residents should contact a private

## **HEAP Winter Crisis Program**

The Winter Crisis Program will take applications until March

2023. The Winter Crisis Program is an energy assistance program, aimed at helping Greater Cleveland residents who have been "threatened with disconnection, have been disconnected, or have less than a 25 percent supply of bulk fuel in their tank to maintain their utility service.

Eligible residents can receive up to \$800 depending on their financial situation.

To qualify, individuals will need to have a gross income at or below 175 percent of the federal poverty guidelines. For a single person, that is \$23,783; the level for a couple is \$32,043.

To apply, residents must schedule an appointment at 216-350-8008 or online at stepforward.itfrontdesk.com. Appointments will be open from 8:00 a.m. until 4:00 p.m., Monday through Friday. To apply, residents must schedule an appointment at 216-350-8008 or online at stepforward.itfrontdesk.com.

Walk-ins will not be accepted. Here is a list of the required documents for applicants to bring to their appointment:

- Copies of most recent energy bills; utility bills (gas and/or electric), regardless of account status.
- A list of all household members and proof of income for the last 30 days or 12 months for each member.
- Proof of U.S. citizenship or legal residency for all household members.
- Proof of disability (if applicable).
- Birth Dates and Social Security numbers for all household members.

It's recommended that applicants submit documentation at least three days in advance to receive assistance.

Documentation can be submitted in several ways: via the Step Forward drop box at 2203 Superior Avenue, through the online scheduler linked above, emailed to Heapdocuments@ stepforwardtoday.org, or submitted online at energyhelp.ohio.gov.

Operation Save-A-Life, a program of the American Red Cross and the Cleveland Fire Department, provides FREE smoke alarms and batteries to Cleveland firefighters at no cost to residents. Please note that application and installation process may take up to 90 days.

#### Why do I need smoke alarms?

Smoke alarms provide an early warning of fire and can increase the chances of a safe escape. According to the Cleveland Fire Department, nearly 75% of deaths in house fires are caused by smoke rather than burns. Children and senior citizens are at greatest risk.

- » Install smoke alarms on every level of your home.
- » Test the batteries once a month. Change them twice a year.
- » Develop a home escape plan in case of fire. Have at least two exits from every room and designate an outside meeting spot.
- » Keep anything that can catch fire away from space heaters. Unplug them when not in use.


