

A Message From Council President Blaine A. Griffin

Dear Residents,

Summer may be over but good news isn't. Most of you have likely heard that Huntington Bank is reopening their branch on Buckeye Road (see more about Huntington's home buying program in the newsletter), the Aura at Innovation Square has opened, demolitions and rebirth is happening as the new Woodhill Homes project continues forward.

Council approved funding to ensure Dave's at Shaker Square remains and improves along with the rest of the square and the historic Hessler Court is being repaved with its original surface, wood blocks. Karamu House celebrated the completion of the Theatre Wing Phase III Renovations. Council granted \$500,000 to support Karamu House in its renovation efforts.

Speed bumps have been installed around the city and expect more next year. Funding for home repairs has passed (more info in newsletter) and I spent the summer being out in the community, including holding two safety meetings. I understand safety is a top concern, and for the rest of the year Council plans to hold hearings on the topic.

Election Day is right around the corner and early voting has begun! This is a very important election and I'm asking you to make a plan to vote and see it through. Cleveland City Council Leadership Reflected on Accomplishments and Set Priorities for 2024-25 Legislative Session

Cleveland City Council President Blaine A. Griffin, Majority Leader Kerry McCormack, and Majority Whip Jasmin Santana convened a press conference to discuss their legislative achievements from the previous session, outline their strategic priorities for the upcoming session, and to announce changes in staffing.

During the press conference, the Council leaders reviewed significant accomplishments from the prior session. They highlighted successful initiatives such as new economic development programs, affordable housing opportunities, advancements in public safety equipment and measures, and improvements in community services. The leaders provided detailed insights into how these measures positively impacted the city and addressed key community concerns.

Looking ahead, President Griffin, Majority Leader McCormack, and Majority Whip Santana outlined their strategic goals for the rest of the year. They emphasized plans to tackle pressing issues, including improving public safety, enhancing economic growth, addressing the redistricting process, and promoting overall community well-being. They also discussed overseeing that American Rescue Plan Act funding contracts and agreements are finalized.

Cleveland City Council Prepares For Upcoming Redistricting

Cleveland City Council must cut two seats ahead of the 2025 municipal elections due to population decline.

Cleveland City Council is eager to hear community members' thoughts about the upcoming Redistricting process. The Redistricting consultants include Bob Dykes of Triad Research Group, Dr. Mark Salling, a prominent demographer and former Cleveland State University professor of Urban Affairs, and Kent Whitley, an urban planner, political consultant, and community organizer.

The City Charter mandates the city use Census data to determine how many members will be seated on City Council. As of the 2020 US Census, the city of Cleveland has a population of 372,624 people, compared to 396,815 people in the 2010 US Census – a 6.10% decline over ten years. Having just fallen under the 375,000-population threshold, per US Census reports, the City Charter mandates that the Council be comprised of 15 members – two less than the current member count of 17.

Feedback collected from community sessions – in addition to US Census data, natural landmarks, and fair distribution of city properties, including but not limited to fire stations, parks, recreation centers, will aid the consultants in draft a map for City Council to approve.
