A Message from Councilwoman Jasmin Santana

Greetings Ward 14 Residents,
We had one of the coldest winters in recent years! But now, with spring finally here, Ward 14 is moving forward with energy and enthusiasm to embrace the new season. Centro Villa 25 has opened its doors and is already becoming a favorite gathering place for the summer. It's hosted several key community events and will continue to be a hub for connection and celebration. Several important projects are also underway across the ward and set to open this year. The St. Michael Convent and new apartments at Blanket Mills are making great progress. Stockyard Park Phase 2 will begin installing its new walking path and picnic shelter this spring, with completion expected by late summer. Over at Trent Park, a major renovation is in the planning phase—and with generous support from the Cleveland Cavaliers, we're hopeful that transformation will begin soon!

That means that over the last eight years, all five local parks in Ward 14 have seen significant improvements—and we're not done yet. This is a community for families, and I remain committed to expanding our parks and green spaces, while also prioritizing infrastructure improvements along Storer Avenue. I'm proud to co-sponsor legislation limiting the number of smoke shops in our neighborhoods. While I strongly support small businesses, I believe our communities thrive when we welcome businesses that uplift and strengthen the area. Limiting the number and location of smoke shops helps maintain safe, family-friendly neighborhoods. As part of the 2025 City Budget, I also advocated for increased youth employment opportunities and more support for our bilingual community members at city meetings. Inclusive and welcoming neighborhoods are a priority, and I'm

committed to ensuring access and equity for all residents. I'm partnering with MetroWest for four community meetings this year to discuss the new shape of Ward 14. Our first meeting took place on March 4, and I'd love to see you at one of the upcoming sessions on May 6, July 1, or September 2 at One Hope NEO. You can also stop by my Open Office Hours on the last Thursday of the month in April, June, August, and October. There's always something happening in Ward 14—sign up for our monthly updates and stay connected. You don't have to go far to learn more, buy a home, or enjoy a park!

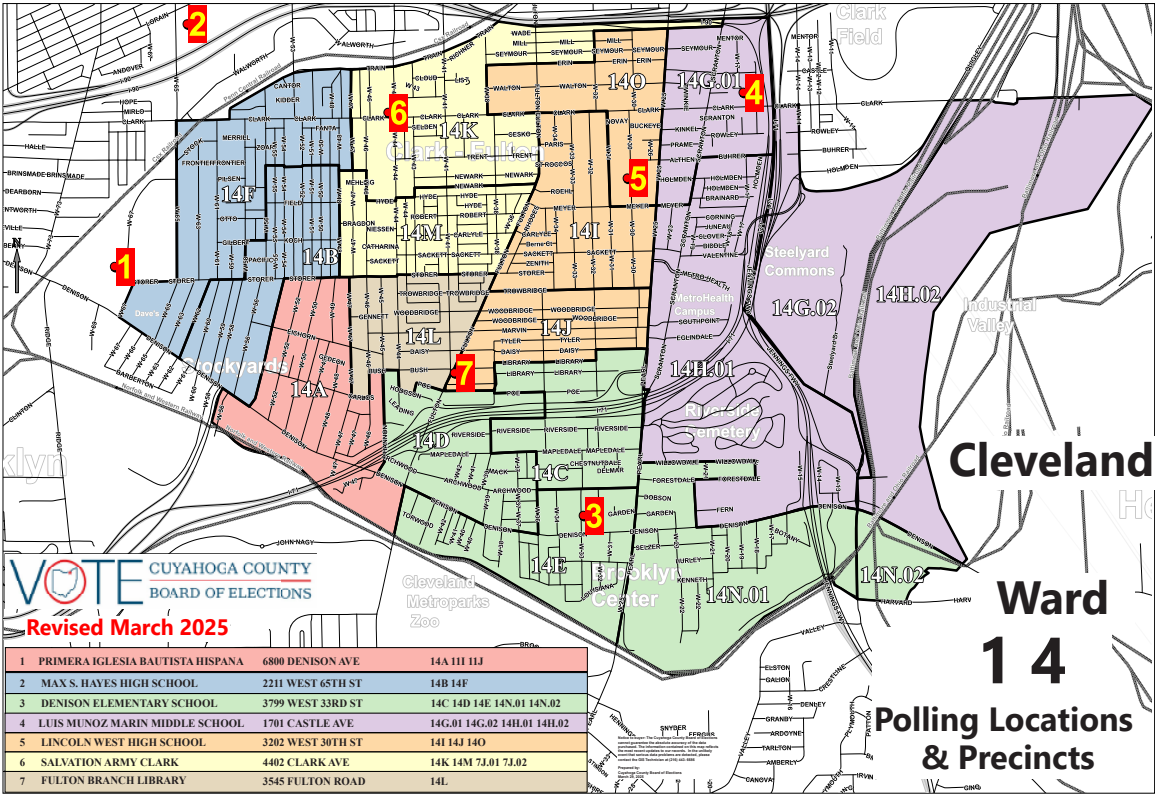

Important Voter News

Beginning in January 2026, Ward 14's boundaries will officially change following a thorough redistricting process influenced by the most recent U.S. Census. Sadly, I will no longer represent the area beyond Denison and Ridge Road, including the W.73rd Block Club. However, the ward is growing overall, and I'll now represent more of Clark Avenue, W.14th, and a greater portion of the Stockyard neighborhood. We'll also be welcoming two new parks and the Clark Recreation Center into Ward 14.

While change can be challenging, I've worked closely with many members of Cleveland City Council, and I know each one of them brings heart and dedication to their neighborhoods. So while I say goodbye to working closely with some long-time friends, I'm excited to say hello to the new residents joining us. Read below about the ward reduction process. I welcome your feedback and kindly acknowledge that while not everyone is happy about these changes, they were necessary due to population shifts reflected in the Census.

New City of Cleveland Ward Boundaries Take Place in 2026

Changes to Voting Locations Take Place Immediately

In January 2025, our City Council completed a mandatory redistricting of the City's wards. This redistricting results from a change to the City's charter approved by Cleveland voters in November 2008. As a result of that vote, the City Charter mandates that Council conduct redistricting after every decennial US Census and that the number of wards be based on the City's population. The 2020 US Census places Cleveland's population at 372,624 people, a decline of 24,000 from the 2010 US Census. With the population dipping slightly beneath 375,000 people, City Council must reduce two wards, dropping the number of ward representatives from 17 to 15, beginning in 2026.

Ward boundaries will change beginning January 5, 2026 - but many voters will see immediate changes to their voting locations. A statewide election is scheduled for Tuesday, May 6. The City's primary and general elections will take place on Tuesday, September 9, and Tuesday, November 4, respectively. Councilwoman Santana: Fighting for Fair Pay for Everyone

Earlier this year, I proudly co-sponsored legislation that will help close the wage gap in our city – **Ordinance 104-2025**. This crucial legislation directly addresses the persistent challenge of wage inequality, which continues to disproportionately affect women and people of color, both locally and nationally.



It's not just about changing a rule— it's about standing up for fairness and equal opportunity.

The reality of the current wage gap is striking: on average, women in the U.S. earn only 83 cents for every dollar earned by a man—with even wider disparities for women of color.

One major reason for this unfairness is that companies often ask job applicants about their past salaries. Studies show that this practice keeps people stuck earning less money. Even if someone is highly qualified for a new role, their previous, lower pay can dictate their new salary. This cycle of underpayment can even be passed down through generations. Instead of evaluating someone's skills and the value of the job itself, companies rely on outdated salary history—leading to lost wages over an entire career and blocking access to essentials like homeownership, education, healthcare, and financial security.

This new law signals that Cleveland is ready to join the national movement for fair pay. It's not just about changing a rule—it's about standing up for fairness and equal opportunity. **By focusing on what people can do and the value of their work, rather than what they used to earn or who they are, this legislation helps level the playing field for every job seeker in Cleveland.**

Numerous states and cities—including our Ohio neighbors Cincinnati, Columbus, and Toledo—have already passed laws prohibiting employers from asking about salary history. And it's making a difference: women and people of color are starting to earn more.

With the support of Councilman Charles J. Slife and Councilwoman Stephanie Howse-Jones, this important law will help make Cleveland a more fair and equitable place for all of us.

Councilwoman Santana Working to Regulate Illegal Smoke Shops

Councilwoman Jasmin Santana has played a leading role in our city's work to address the excessive number of smoke shops that have opened throughout the community. She served as a co-sponsor for four new laws that aim to limit the growth of these shops and create common sense rules for them. Through conversations with residents, business owners, and others, Councilwoman Santana is aware that people are concerned about the negative effects that too many smoke shops in a concentrated area could have on people's health and the character of neighborhoods.

The Councilwoman has helped push for emergency rules that temporarily stop new smoke shop permits. This will give the city time to develop better, more comprehensive regulations and strategies to enforce them.

These new rules, which Councilwoman Santana strongly supports, aim to find a balance between allowing businesses and protecting the well-being of people and neighborhoods in our neighborhood, as well

as across Cleveland. The laws include things like **requiring smoke shops to get licenses, conducting health inspections, and restricting their proximity to places like schools and parks.**
