**Please state your reasons for desiring to serve on the Commission.** As a lifelong resident of the Cleveland and Greater Cleveland area, I am someone who is deeply passionate about the city and the well-being of its citizens and larger community. It troubles me deeply to see the continuing issues between the Cleveland Police and citizens, often with deadly results, and as someone who believes in objectivity, empathy, awareness of how complex issues inform relations, and as someone who has seen continued degradation of the aforementioned relations, I think it is clear that the current model is ineffective and the need for independent oversight is stronger than ever.

## Please describe any skills, life experiences, and expertise that would qualify you for an appointment.

As someone with a master's in math, I am extremely data-driven and logically oriented. On the other hand, as someone who teaches classes that examine complex interactions of culture, history, law, and societal norms, I am well-versed in how these complex mechanisms and systemic structures inform and influence individual events. Lastly, with a degree in psychology, I am well-versed in the behavior of individuals. I believe that my data-driven training, in combination with an understanding of broader history and culture and understanding of individual behavior help me to see these issues from all sides.

## Please describe how you see the oversight role of the new Community Police Commission impacting policing in Cleveland.

I see the role of the new Commission as having two main aims. The first is at the level of individual incidents, in providing evaluation of and feedback on such incidents and related subsequent events, as well as recommendations regarding and ordering of action to correct inappropriate punishments, retaliation, decisions, and/or remediations, or lack thereof.

The second level is at the broader scale and takes a proactive stance as opposed to the reactive evaluation of individual incidents. This means engaging with disenfranchised comminities, developing policies, increasing accountability, eliciting public feedback, improving training, and improving community relations. The ultimate goal is that individual incidents are greatly reduced or eliminated through the implementation of these broad-scale services and policies.

As someone who has lived in the Cleveland area, earned his degrees in Cleveland, and currently works in Cleveland, I am both deeply passionate about the city and my fellow citizens and well-versed in its history. Much of my current academic work revolves around issues of racism and sexism and its intersections with culture, society, and history. My background in math and psychology also inform my ability to objectively evaluate data and understand human behavior. That being said, as a white man, I also understand my position of privilege and work tirelessly to learn the perspectives and experiences of others and to amplify disenfranchised voices.
