I believe that the commission needs to have persons who understand the concerns of the consituency of the city of Cleveland. I've known people who feel they have been mistreated by police, but I've also seen the police misunderstood and maligned by the public and the media. We need objective, fair and open minded people who can apply laws and standards with a common sense approach. It is something I am passionate about because it is imperative that police and community relations improve so our city can prosper.

Please describe any skills, life experiences, and expertise that would qualify you for an appointment.

I am a former Institutional Guard for the Cleveland Divsion of Police (1996-2000). I was trained for the position at the Cleveland Police Academy. I had to follow the rules and General Police Orders while employed at CPD.

I come from a law enforcement family. My father and uncle are retired Cleveland Police detectives and several cousins also served on CPD. Police policy and application was a regular discussion among relatives. Even though they were police officers they could empathize with the fairness presented to suspects. They were also aware of the negative culture among some officers within CPD toward minorities and other groups.

I am used to working with various segments of the public. For the last 17 years I have worked with CMSD students and their families. Some have had the misfortune of being involoved in the criminal justice system. The mental health and social skills of many of these young people and their familes are often a barrier to having positive relations with their neighbors, law enforcement and other community entities.

Please describe how you see the oversight role of the new Community Police Commission impacting policing in Cleveland.

I believe that the board has a clear mandate by the citizens of Cleveland to bring fairness to investigations and hold law enforcement accountable when warranted. The Community Police Commission must instill public trust that all investigations will be fair and impartial. If the board functions as designed, trust can be restored for both the public and CPD.

The CPD has been mandated to change through the consent decree. Much of the change revolves around attitudes and culture. The Community Police Commission can assist with the paradigm shift inside the CPD.
