While in college during the finals week of my senior year at the University of Toledo I was stopped for an apparent traffic violation, I did mistakenly turn right on red when that turn was not allowed. I stopped and shortly thereafter I was arrested for possessing drugs. I was asked in an interrogating type of conversation sitting in the back on the police car if I could give them a name of anybody to turn to get myself out of this. When I did not provide them a lie I was booked into the Lucas County jail. Eventually I was exonerated but that experience highlights my experience in dealings with law enforcement.

I was also able to meet with Police Officers as well as the President of the CPPA to gain as much knowledge from their perspective as possible. I do believe that our city and surrounding cities would become much better once we are able to become a society where the people can absolutely trust law enforcement, and law enforcement can absolutely trust the people.

## Please describe any skills, life experiences, and expertise that would qualify you for an appointment.

I have the unique ability to process information from all sides without emotion. I understand the importance of fairly considering all information equally. In my life I have been the teenager/young adult who was harassed by officers, and now as an adult I am able to speak to many officers to shed light on certain challenges. As a young profession I worked in a gang outreach and prevention in Slavic Village. I have been a Juvenile Probation Officer for 10 years and currently as an Intake/Diversion Officer I have years of experience reading and processing police reports. I have years of experience of working with young people who are adamant they did not commit a crime. I further have the experience of working with those young people in the months and years following the incident in question and observing how one incident could effect a young person and at times an entire family or community. I take my work extremely serious. I speak to my co-workers and supervisors daily, I speak honestly and truthfully about how we handle situations and how we could be more effective.

## Please describe how you see the oversight role of the new Community Police Commission impacting policing in Cleveland.

I do see the Community Police Commission having a tremendous and positive impact on Cleveland Police. I have had numerous opportunities to speak my councilman several times and he told me that Cleveland Police has been in the process of transforming for some years and the new younger officers are being trained to do things in a much better way. I believe the statement and with that being said I further believe that knowing there is a real checks and balance system in place here Officers will be less likely to intentionally wrong someone. I believe citizens will develop more of a sense that a fair body will consider conduct in a fair and timely manner. I believe that eventually both sides will be better off as a result. I also believe the initial considerations will go a long way to decide how soon the positive impact is felt by the citizens and the officers alike.

I am part of the initial group to start the Cleveland Peacemakers Alliance to help curb gang violence. I have now worked at Juvenile Court for 12 years in Probation and now Intake/Diversion.
